Windsor a Precursor?

- The State of New York recognizes the marriage of New York residents Edith Windsor and Thea Spyer, who wed in Ontario, Canada, in 2007. When Spyer died in 2009, she left her entire estate to Windsor.

Real Money

• Windsor sought to claim the federal estate tax exemption for surviving spouses, but was barred from doing so by §3 of the federal Defense of Marriage Act (DOMA), which amended the Dictionary Act—to define "marriage" and "spouse" as excluding same-sex partners. Windsor paid \$363,053 in estate taxes and sought a refund, which the Internal Revenue Service denied.

Federal Recognition and Response

- Windsor was decided in June 26 of 2013
- Federal government then started a review of what agencies should do
- Department of Labor and Internal Revenue Service issued guidance requiring federally regulated benefits, such as tax-qualified retirement plans--ie the same benefits to same-sex spouses as any marriage
- Less clear for employers and others—welfare and health care benefits, etc.

Lex Loci confusion no more? Lex Loci Celebrationis

- After Windsor, but before the Obergefell decision, attorneys dealing with same sex marriage often asked:
- Where is your residence?
- Where were you married (and when)?
- Have you moved from one location to another?
- Was the marriage valid in your "marriage state, and how does your state of residence treat such marriages?
- <u>Tip</u> Never use this Latin with clients

Domestic Partnerships/Civil Unions Soon Dead as a Dodo?

- Before Windsor, and even after, several employers and some union contracts made allowances for various benefits for those in Domestic Partnerships and Civil Unions, however they may have been defined.
- This particularly happened in jurisdictions that did not recognize same sex marriage.
- After Windsor and especially after Obergefell, there likely will be a retrenchment of such largess—some of that has already happened.

- Often a matter of contract negotiations so changes likely to come in next few years Tip Inquire of your client

Obergefell

- After two decades together, his partner now facing debilitating amyotrophic lateral sclerosis (ALS)James O was determined to marry John Arthur and both flew by medical transport plane to be married in Baltimore
- 3 months later, Arthur died, and Ohio said no way O could be listed on death certificate as surviving spouse

Who are

April DeBoer and Jayne Rowse

- Michigan nurses who celebrated a commitment ceremony to honor their permanent relation in 2007
- Fostered and adopted children including one needing around the clock care
- Michigan, however, permitted only opposite-sex married couples or single individuals to adopt, so just one legal parent/standing

Fundamental Right

- In Obergefell the majority held that the 14th Amendment required states to recognize same-sex marriages, calling the right to marriage a fundamental right under Due Process and Equal Protection Clause analysis
- Dissent_- not truly a "liberty interest" and court decision stretches meanings of fundamental rights—legislation is better



What now? Clients

- Don't assume that all same-sex partners, even longterm partners, plan to marry—how will marriage change their standing?
- When advising a same-sex couple about marriage, it's important to have a complete picture of the couple's income and assets
- Many married clients believe that a married person does not need a health care power of attorney

- Use language to signify importance? i.e.: "...my good friend and long-term companion..."
- Intestate succession NOT what many lgbt individuals desire/plan/understand
- Traditional or not, basics of estate planning remain

The 3 Legs of the Stool

- The 3 most basic items for good life and estate planning in Michigan are:
- --Durable Power of Attorney for Finances
- --Designation of Patient Advocate (Medical Power of Attorney)
- --Will

- The writer reminds us that In 1923, "heterosexuality" made its debut in Merriam Webster's authoritative New International Dictionary. "Homosexuality" had, surprisingly, made its debut fourteen years earlier, in 1909, defined as a medical term.
- Took on mantle of "normalcy" for many years

Terms/Slurs/Humanity

Kinsey (1948) and American Psychiatric Association (1973)

- As Katz noted: Kinsey popularized the idea of a "continuum" of activity and feeling between hetero and homo poles:
- "Only the human mind invents categories and tries to force facts into separated pigeonholes. The living world is a continuum."—Dr. Alfred Kinsey
- APA deletes homosexuality from their list of psychiatric disorders in 1973. Diagnostic and Statistical Manual of Mental Disorders (DSM)

Transgender & Transvestite

- Transgender: a person whose gender identity does not correspond to that person's biological sex assigned at birth
- Transvestite: a person, typically a man, who derives pleasure from dressing in clothes appropriate to the opposite sex.

Transsexual and Gender Dysphoria

- Transsexual-people who find themselves experiencing a gender identity not congruent with their "assigned" sex -often viewed as adjective--and typically people in transition by way of living the life of the sex they hope to be, hormone therapy and sex reassignment therapy.
- Gender dysphoria or gender identity disorder-medical term or diagnosis.

Heterosexual/CIS/Straight

- Having sexual attraction to members of the opposite sex; sexual feelings for those of the opposite sex.
- Cisgender—a linguistic approach to describe someone feeing a connection or match between their "assigned" sex and the gender they feel themselves to be.
- Straight-slang for "normal" or opposite sex attraction, activity, etc. Rare among youth? http://www.dazeddigital.com/artsandculture /article/25945/1/half-of-young-people-dontidentify-as-straight

Bisexual

 Bisexual--the potential to be attracted, romantically and/or sexually, to people of more than one sex (and not always at the same time or to the same degree or same way).

Homosexual/Gay/Lesbian

- Homosexual a person attracted romantically or sexually to a person of their same sex.
- --Gay—although often used as an umbrella term for anyone with same sex attraction, more often used for males attracted to males—typically viewed as a positive term within the community.
- Lesbian—female who experiences romantic love or sexual attraction/activity with another female.



Why put LGBT together?

- If the LGB of LGBT is most often a description of attraction or possible activity—maybe even orientation and sexual acts, and the T is typically seen as a matter of sexual identity that differs from a birth identity, why combine these?
- Some say these populations shouldn't be put together—and one can read about political struggles by advocates.
- The main reason these are often seen working together? Whether sexual orientation or gender identity-these people fall outside the "norm" and so they have common issues as relates to law, policy, prejudices, etc.

Approaches-People First

• Core or fundamental skills of a mediator are many. They include building rapport, suspending judgment or bias, displaying empathy. Also a good mediator must be adept at trust building, framing or reframing issues, facilitating negotiation, discerning real needs and interests, all while keeping in mind diversity and cultural competency issues and participant dynamics.



Possible Baggage

-might it affect empathy, power in mediation, terms, mediator neutrality and cultural competence, willingness of both parties to find common ground?
